About Newton County Summer Camp: Newton County Summer Camp is a 4-week long summer day camp for ages 5-12. We will provide themed activities that promote development, discovery, leadership, imagination, and creativity. These activities will be fun-filled, hands-on, and involve plenty of movement. Campers will be grouped into smaller teams led by two or more counselors. We are experienced professionals who will hire dependable volunteers in our area to ensure the safety of the campers.

Campers and Fees: Campers must be ages 5 to 12. Advanced registration is recommended, because space is limited. The weekly fee is \$25 per child per week. The fee must be paid every Monday of the week at the registration table in the auditorium. However, discounts may apply for those with multiple family members who attend within the same week. Payments and/or scholarships information must be received to ensure enrollment. There will be NO refunds for cancellations or partial registration. Newton County Resource Council is providing scholarships to enable all kids to participate.

Days & Hours of Operation: The camp will be Monday - Friday 7:30 a.m. to 3:30 p.m. Campers will check in each morning at the camp registration table by the Jasper Auditorium. Drop off & sign in is from 7:30 a.m. to 8:00 a.m. in the Jasper School Auditorium. Breakfast will be from 7:45 – 8:15. Those campers arriving later than 8:15 will not have an opportunity to eat breakfast at camp. Please be sure to notify the staff at least a day in advance if you know your child will be late so arrangements can be made to get them to the correct location with their groups. Pick up is promptly at 3:30 p.m. at the auditorium. A late fee will be charged after 3:30 p.m. unless prior arrangements have been approved with the camp director. The late fee is \$5 per minute. All changes to child's pick-up arrangements must be made BEFORE 2:30 each day.

Discipline: Good behavior & respect of others will be expected at all times. If a behavior problem cannot be resolved by the staff within a reasonable time, the child's parent or guardian will be contacted to pick up the camper for the remainder of the day. Camp staff will not use corporal punishment.

Photography: Your child's photo will be taken & may appear on websites, newspaper ads, & other social networking sites. By signing this registration form you are giving us permission to use your child's photo. If you do not want your child's picture to be used please attached a written request and attach it to this document.

Sign In & Sign Out: It's very important you bring your child to the sign in station each morning & sign them in. This is also a great time to give any special instruction or change of information to the camp staff; please write a note of the special direction and leave with a counselor/director. Children will only be released to those listed on the registration form. If an unauthorized person attempts to pick up the child, a camp staff member will keep the child, and the parent will be contacted by phone. Photo identification may be required if the staff does not recognize the child's parent or guardian. EMERGENCY PHONE NUMBERS ARE REQUIRED FOR EACH CAMPER.

Dress Code/Personal Devices: Campers should dress as if they are going to school but be comfortable. No tube tops or extra-long tank tops that show a lot of skin or similar clothing should be worn. Athletic shoes & water shoes should be brought daily. Flip-flops & sandals are ok to wear most of the day, but should not be the camper's only shoes. We will be walking very frequently, so please provide your child with comfortable shoes that do not cause blisters. Campers will be responsible for bringing an appropriate swimsuit each day. If your child does not have a swimsuit they will not be permitted to swim. Sunscreen is always a good thing! Please send sunscreen with your child each day too! All hand-held cellular items are not permitted. These items may be permitted for bad weather. We will post on our Facebook page when campers will be allowed these items. 4H, the Summer Camp, Camp Staff, or any other organizations will not be responsible for lost, misplaced or stolen items.

Swim Time: Campers will have approximately 60 minutes of swim time each day (weather permitting). A licensed lifeguard, a member of the camp administration, and several camp counselors will be on duty for the duration of swim time. Before campers are allowed to swim, they will be given a swim test and assigned to an appropriate swim area depending on their abilities. Students who require their own life jackets will be responsible for bringing it each day. Campers will be continually monitored to ensure their safety.

Breakfast, Lunch and Snacks: Jasper Public School will provide breakfast and lunch each day. We will also provide one snack per day. If your child has an allergy, he/she may bring their lunch. You are responsible for providing meals if your child has any dietary restrictions.

Sickness and Injury: Camp will keep a medical release on file. In the unlikely event your child needs immediate medical or surgical aid we will call Emergency Medical Services first, & then parent or emergency contact listed on the registration form. Staff members are trained in CPR/AED & First Aid. The staff will not administer medication(s). Sick children should be kept at home. Parents will be contacted to pick up a child who shows signs of illness.

Communication: Please keep in mind that cell phone service in the school/other designated areas can be unpredictable. With that being said, we will post all necessary information on the "Newton County Summer Camp" Facebook page. We will also be creating a Facebook messenger page that includes at least one parent/guardian of each child. We understand that emergencies occur unfortunately, and we will deal with them on a day to day basis. If you have an emergency and are not able to reach the director/assistant director, please call Jasper school at 446-2223. If you do not have Facebook we will accept written notes left at the registration table. Keeping your kids safe is our number one priority, and communication is the key to doing this! We take it very seriously, and expect the same in return. Thank you for your patience and understanding!

Field Trips: We will be going on several fun field trips this year! By signing this form, you are giving us permission to transport your child to and from these activities. Some of our trips will be by foot and others will be by bus. You will receive a paper schedule of the day, time, and location of these trips. If you do not want your child to attend a field trip you need to let a supervisor know and keep your child home for the day.
